CHINA FISH 2026 HOTEL VOUCHER

I. Hotel Voucher Terms & Conditions

Hotel Voucher can be used to cover the following charges incurred at the China Fish official Hotels booked by China Fish 2026 buyers (excluding room rate):

- **Food and Beverages** (including in-room dining)
- **Other Internal Hotel Services:** laundry and dry-cleaning, spa services (where applicable), etc.

Exclusions:

- Third-party service (e.g. external car rental, tour guides, or off-site restaurants)
- Fees for damages (e.g. room damage repairs, extra cleaning charges)
- Any other fees not officially provided by the hotel.

The final interpretation of eligible items is subject to the hotel policy. In case of any dispute, China Fish will have the final authority for resolution.

II. Eligibility Criteria

The voucher is applicable only when all of the following conditions are met:

1. **Registration:** Must be an International Buyer who has completed official registration for China Fish 2026 on or before January 30, 2026.
2. **Booking Channel:** Bookings must be made through China Fish official channels at its China Fish hotels. The guest's name must match the registration information.
3. **Stay Duration:** A minimum stay of 3 consecutive nights is required, which must include at least one night between February 28 to March 2, 2026
4. **Valid Period:** This voucher is valid only for use at the hotel where the booking was made from February 26 to March 5, 2026. It will expire automatically after this period.
5. **Others Terms:** This offer is limited to the first 200 bookings and is available on a first come, first served basis.

1. **Issuance:** The e-voucher will be sent to eligible customers via email. To redeem, present the e-voucher at checkout for verification and direct deduction from your final bill.
2. **Verification:** A valid passport must be presented upon check in. The guest's hotel registration information must match the passport details.
3. **Redemption Process:** All the incidental charges (e.g. room service, F&B) must be charged to your room account. The voucher can only be applied to settle the accumulated charges upon checkout by presenting the voucher.
4. **Usage Limit:** One voucher is applicable per eligible room reservation and can be used only once. Any unused balance from the voucher will be forfeited and can not be used for further transactions.
5. **Other Restrictions:**
 - This voucher is non-transferable, non-resalable, non-refundable
 - It has no cash value, and no change will be given for any unused portion
 - The voucher is valid only for expenses incurred during the stay at the booked hotel. It can not be applied retroactively after check out.

IV. Cancellation and Modification

1. For any cancellation or modification to your booking, you must notify our designated contact at your earliest convenience and comply with the respective cancellation and modification policies of both the hotel and China Fish.
2. The voucher will be automatically voided and not reissued if the cancellation or modification to the booking results in the reservation no longer meeting the eligibility criteria.
3. The voucher will be automatically voided should it become unusable due to the exhibition adjustments or force majeure events.

V. Other Terms and Conditions

1. China Fish reserves the right to revoke the user's voucher eligibility in the event of any breach of these terms.
2. Matters not covered herein will be interpreted and amended by China Fish, which holds the final right of interpretation.
3. The terms are provided in both Chinese and English. In case of any discrepancy between the two versions, the Chinese version shall prevail and be legally binding.
